6.	<p>General Business</p> <p>The following topics were raised in general business:</p> <p><u>Net Zero Plan</u> - Kylie announced this has been adopted by Council and will go on public exhibition in a month or so, A copy will be sent to members of this group.</p> <p><u>No new gas</u> – Clr Pedersen stated she had tried to have this issue address in the Net Zero plan. Weeds and native grasses – Clr Pedersen mentioned a recent and informative talk on this topic by Philip Ward.

Change to mowing centre strips on main roads – Clr Pedersen noted that a recent change to government policy will see grass replaced by slow growing natives on nature strips such as Lane Cove Road. This will also assist with grass clippings which currently go down drains.

Solar my schools – Jo Taranto asked if Council has a budget to support this. Kylie will send the link for the pilot scheme being trialled for schools.

Link to Solar Schools State Government pilot program to be forwarded to Jo Taranto

Subcommittees of this working group – Shu-fang suggested sub committees to consider items such as education on composting be considered. This will be discussed at a future date.

Community garden and verge policy – Jordan asked for an update. Staff advice was that an application for a community garden at Putney has been received. The verge policy is separate and faces constraints such as underground services, power poles line of sight issues etc.

Staff to provide an update on the verge policy next meeting.

Herbicides used by Council – Jordan noted the use of roundup in bushland parks. Staff advised the use of herbicides is undertaken carefully as spot spraying targeting specific weeds.

Use of fungus as a biocontrol agent – staff advise that the Kordyana brasiliensis fungus is being trialled in Darvall Park to control tradescantia in partnership with the CSIRO

Weed control – Jane noted that weeds are a greater problem following the wet weather over recent months. Staff advised that Council is targeting priority weeds and vines. The weeds officer is working with private land owners to control weeds on their land.

Volunteers and COVID – John asked how COVID had affected volunteer numbers. Staff advised volunteers have increased in number.

How do ideas from this working group get into the community - Shu fang. Staff advised that when main ideas are formulated by this group, they may be woven into Council's current plans.

Small to medium business – Jo asked is this group being catered for. Staff advised that business resilience, waste etc will be addressed in Council's Net Zero Plan.

Ryde Hospital site – Clr Pedersen asked whether any of the committee members are aware of what is being proposed for the 1ha of natural area at this site.

Bush therapy – Clr Pedersen noted that bush therapy workshops were being offered locally.
