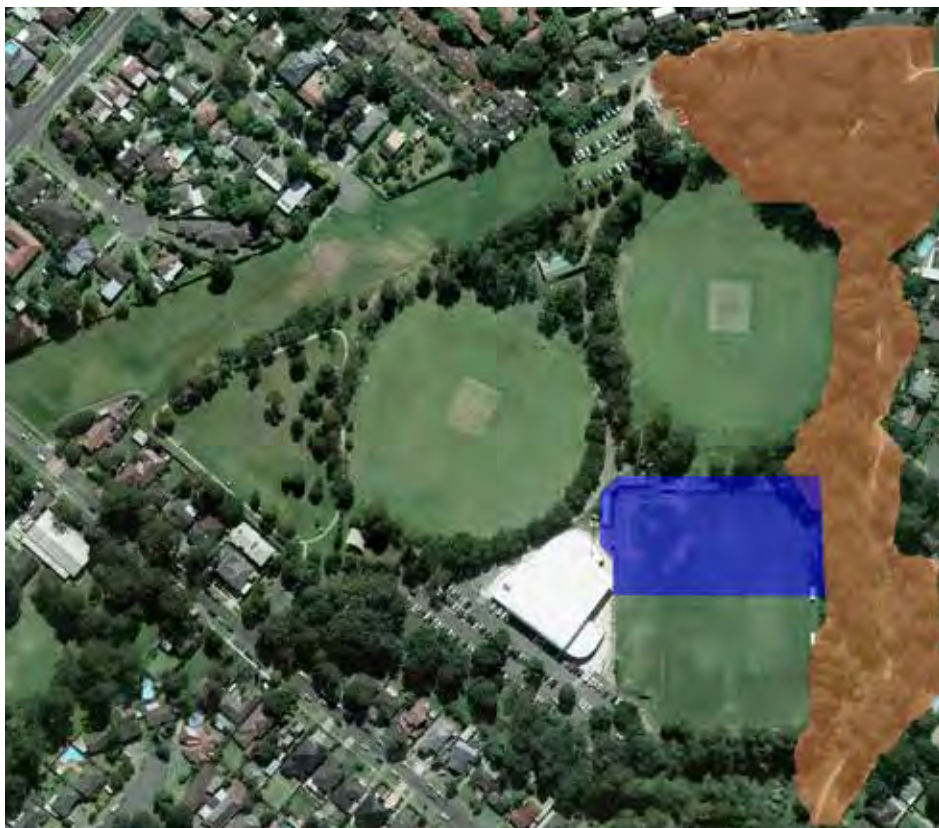
Upgrade works currently in progress

Baseball upgrade to field 2:

Field 2 currently contains a major baseball facility for the area. The current infrastructure requires some renewal works to preserve the facility for future use. The upgrade will include: the renewal of batting cages and dugouts, a new storage area, new fencing and drainage works. These works are scheduled for completion by mid 2016*.

Tree works in Shrimpton's Creek:

A number of trees in the lower section of ELS Hall Park along the shared user path were identified as being in poor structural condition. Tree work has been completed and Council is undertaking restoration works and a Termite Management Plan to manage the impacts on the vegetation. These works will occur over the coming months.

Upgrade works about to commence

Floodlighting renewal to field 1:

As part of our sports floodlighting renewal program, Council is currently updating the floodlights for field 1. Completion of these works is expected by Christmas 2015*.

Drainage upgrade:

As part of Council's Floodplain Risk Management Plan, Council are committed to providing effective management of its drainage assets. Therefore Council will be regrading and clearing the existing drainage swales (stormwater channels) to capture the rainwater, so it doesn't flow down on to the fields. These works will be integrated with the delivery of the shared user path and upgrade to the dog off leash area.

Installation of a shared user path:

A shared user path will also be installed that will connect Adelphi Road to Scott Street and Kent Road. These works will be split into two stages over a two year period. Stage 1 is the Scott Street to Adelphi Road path which is scheduled for completion before mid 2016. Stage 2 is the Adelphi Road to Kent Road path which will commence once stage 1 is complete. Stage 2 is scheduled for completion before mid 2017.

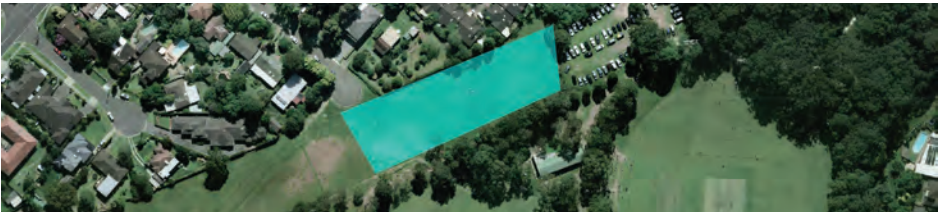
Submissions must be received by Sunday 29 November 2015. Written submissions must be clearly marked 'Dog off Leash Upgrade at ELS Hall Park'.
