- Each day, 60,000 people leave the Ryde area to work but 85,000 come into the city to	
work;	
<ul> <li>Macquarie Park is central to this influx of employees;</li> </ul>	
- Drivers and passengers make up most trips;	
- Bus, other and train make up 13%;	
- There is lots of scope for people to use bikes more often to get to work, although it is	
usually considered a recreational activity;	
- To reduce traffic in the future, there needs to be change in driver behaviour now, through	
working from home, using alternate transport forms etc;	
<ul> <li>A team is looking at the missing links in bicycle pathways which should help in encouragil</li> </ul>	na
travel by bike;	ing
- Medium/high density housing continues to increase, and employment and housing will	
continue to increase in the area;	
<ul> <li>There are 3 transport spines in the City which all have pinch points;</li> </ul>	
- Competitive public and private transport options, are needed, especially in Macquarie Pa	rk;
- In 2007, Council produced its first ITS with the aim of finding ways to reduce air pollution;	
<ul> <li>The current strategy was completed in 2015 with the aim of finding the missing links in all</li> </ul>	
forms of transport;	.
- The 2015 Strategy, made 72 recommendations;	
- The latest strategy being undertaken now is looking at advocacy to fund missing	
infrastructure and links;

-	It is hoped to continue what is working well and improve in areas that are not	
-	Connectivity is very important – people want connections to centres, open space, etc	
-	People want to be able to use ebikes to do anything they want in Ryde. This should be	
	possible – it is not at present To deliver bike infrastructure is expensive – it takes years to deliver an entire route	
-	A question was raised as to whether pop-up routes can be created as occurred overseas	
-	during COVID?	
-	Not much data exists at present, but need to capture this so it is understood what people	
_	think	
-	Mark asked if this strategy will work to change that – the answer was yes. No point making	
	decisions without having data to back it up,	
-	Sometimes it was noted there is conflict between different groups over the same issue ie	
	with regard to the use of granite for footpaths/ shared user paths, it might look good but is	
	slippery for bikes. Need an overall decision process so everyone is involved	
-	Need to give people the chance to take part in decision making process	
-	It was noted that Macquarie Park has good connections. The connection between Epping	
	and Mac Park is good and the connection between Eastwood and Mac Park is improving.	
-	Bike connections in the Gladesville area are poor	
-	There are lots of green routes in the CoR and possibly Shrimptons Creek could be used too	
-	It was noted that it is often the last mile which is missing when people catch public transport	
	but need to get to their final destination.	
-	Bike lanes, shared lanes are the major method of bike use on major routes	
-	On local roads, the markings are not as obvious and often affect parking provisions	
-	Healthy Streets framework from the UK is considered a fantastic opportunity to improve all	
	streets, not just for cyclists but for everyone	
-	It puts people and their health at the centre of decisions	
-	If people choose to cycle and walk and feel welcome, you have created a healthy street	
-	Mark noted that this approach takes a whole of community approach and lessens the	
	potential for people to only look at issues from their own point of view be it a motorist,

3.	Bike programs – update- Lisa could not be present but provided the following information,	Noted
	- I am currently working on the education program to target shared use path behaviour (both pedestrian and cyclist) – we are going to update the existing 'Walk. Ride. Share.' campaign and use the tagline 'Look out for each other' or 'Watch out for each other' and create signage and fence banners. We will run a social media campaign along with promotion through various council and other networks. We will start rolling out in April as we have a feature piece in the April Rates Notice City News. This is in response to the NOM regarding pedestrian safety on SUPs.	
	- I think we need some input from the Bicycle Advisory Committee on how to address speed and group riding on SUPs - whether we can consider limiting group rides on the Ryde Riverwalk, or if there are any other measures that could be taken. Otherwise we can roll out this education campaign and review the situation later in the year.	
	<ul> <li>We are running a Bike Maintenance Workshop and free bike checks for seniors as part of the Seniors Festival in April. This workshop and free checks will be held on Friday 23 April at Meadowbank Park netball courts in the car park from 10am – 1pm.</li> </ul>	
	- We have had some varied responses within Council to the suggestion of holding a bike skills workshop on Anzac Day afternoon (the venue was unavailable for use on the other proposed dates). Could the Committee please make a call on whether this is appropriate. If so, I will confirm the booking of venue and begin promotion.
