|    | <p>What do the changes mean for people with disability?</p> <ul style="list-style-type: none"> <li>The law provides improved safeguards for people accessing NSW Government-funded disability supports and services from now until the full roll-out of the NDIS. These safeguards include new employment screening requirements and the need for disability supported group accommodation providers to report abuse, neglect or injury of people with disability to the NSW Ombudsman.</li> <li>The new safeguards apply to both government-operated and government funded disability services, including those services funded through the Community Care Supports Program.</li> <li>The law also includes some new provisions relating to the provision of disability funding to individuals and organisations.</li> </ul> <p>2.
