## Excessive Development – Ryde Says No

The City of Ryde will once again be voicing its opposition to even more examples of excessive development within the community.

Council will be opposing two major proposals in Meadowbank. One seeks an increase in height from 10 to 15 storeys, and the other seeks an increase in height from up to approximately seven storeys to approximately 27 storeys

Like many of you, I've had enough. Our schools are over-crowded, our roads are choked, and our open space is under threat. A much more balanced approach to increased density should be the norm.

Yet what we have seen to date in Macquarie Park is a State Government prepared to rezone large swathes of land to high density residential, without the infrastructure to back it up.

Along Epping Road, from Epping to North Ryde, the state has changed zonings to allow for approximately 13,000 new apartments. And believe it or not, they're not done vet
