Taking action to combat climate change

Councils have a vital role to play in addressing climate change. As part of our commitment to tackling this important issue, I am very proud to announce that the City of Ryde has joined forces with 70 local governments to become a member of the Cities Power Partnership. Through this, we have pledged to take action in five key areas. This includes sustainable transport solutions, increasing renewable energy production, installing energy-efficient lighting and implementing education programs for Council staff, local residents and our business community.

One way Council is doing this is by harnessing the power of the sun to generate electricity for some of our community spaces, with solar systems installed on North Ryde Library, Ryde Aquatic Leisure Centre and Eastwood Community Hall.

Renewable energy is a win-win for Council and our environment, and Eastwood Community Hall's system has the potential to offset about 12 tonnes of carbon emissions per year. That's the equivalent of permanently taking four cars off the road. Next time you're in Eastwood, check out the shiny new solar panels on the hall's roof!
