112 Talavera Road planning proposal approved by NSW Government

Despite opposition from the City of Ryde and the community, I can confirm that the State Government has approved a planning proposal which will allow for a 63-storey residential building at 112 Talavera Road in Macquarie Park.

The planning proposal was approved by the State Government after its moratorium on existing planning proposals in the City of Ryde was allowed to expire.

In December 2018, Council recommended that the planning proposal be refused on a range of grounds including a lack of supporting infrastructure and the fact that the increase in building height and density was not in the community interest.

The decision by Council to recommend refusal also came after the planning proposal was placed on public exhibition. More than 400 submissions were received during this period of community consultation, of which the vast majority were against the planning proposal.
