Coronavirus updates

The City of Ryde has made the difficult decision to cancel several upcoming major events following Government advice that events with 500 or more expected attendees must not take place.

Major Council events to be cancelled in the coming weeks include Harmony Day, scheduled for 21 March, and the West Ryde Easter Parade and Fair, due to take place on 4 April. The 9 April Citizenship Ceremony will also be cancelled.

What Council is doing to help

Council has established frameworks for a range of scenarios to ensure it can continue to operate with minimum disruptions and deliver effective services and support to the City of Ryde community during this time.

Casual staff members who are required to self-isolate will have their casual shifts honoured for up to two weeks. Curfews have also been lifted for delivery trucks for two weeks in the wake of shortages of critical supplies at local supermarkets.

This will ensure enough supplies can be delivered to restock supermarket shelves.

City of Ryde has also initiated improved hygiene protocols for Council operations and events, pending further advice from Federal and State governments.

Immunisation clinics for kids

Council has been providing an immunisation service to our local community for over 50 years.

This service is available for all children from newborn to five years of age regardless of place of residence. Vaccines are administered according to the NSW Immunisation Schedule, which help protect against a range of infections including measles, mumps, rubella and tetanus, among others.

You do not need a Medicare card to attend our service and no appointment is necessary.

The next immunisation clinics are being held at West Ryde Hall, 1A Station Street, West Ryde on Tuesday 24 March from 9.30 – 11.30am and 6.30 – 8.30pm. To find out more, visit www.ryde.nsw.gov.au/
