

6 GLYPHOSATE USE IN THE CITY OF RYDE - Councillor Penny Pedersen

MOTION:

That, given recent publicity and community concerns regarding the use of products containing Glyphosate for weed control, the General Manger bring back to Council a report outlining:

- (a) The use of herbicides that contain Glyphosate in all City of Ryde Council owned and managed areas.
- (b) A list of herbicides and procedures and their estimated cost to implement at the City of Ryde, that are effective in controlling weeds which could be used to replace products containing Glyphosate.
- (c) The current safety advice from Australian state and federal agencies regarding the use of products containing Glyphosate and current practices of neighbouring councils.



7 NAMING OF 1ST PUTNEY SCOUTS HALL IN HONOUR OF ALISON SMALL - Councillor Roy Maggio

BACKGROUND:

The 1st Putney Scout group wishes to acknowledge the contribution of Alison Small (Leader in Charge/Cub Scout Leader) by honouring her legacy with the naming of the scout hall after her "The Alison Small Putney Scout Hall".

Alison Small has been a Cub Scout Leader for 30 years and inspires both the Cub Scouts in her Pack and the Leaders she has mentored to Do Their Best at all times. She has the respect of her Cub Scouts, the Leaders and the families of 1st Putney Scout Group. Alison or "Akela" plans a diverse and adventurous weekly program that engages and inspires her Cub Scouts teaching them the tenants of leadership and responsibility. She involves her Cubs in the program development which often leads to camps, hikes, and major events like Cuboree (a five day four night camp). Alison encourages the young people in her charge and challenges them to achieve their Boomerang and Grey Wolf Awards and supports them every step of the way. She offers words of encouragement to those young people working toward their awards and helps them set and achieve their goals. Alison is an outstanding example of active and engaged citizenship.

Alison was also a recent nominee for the Ryde Citizen of Year 2018.

If Council agrees to this initiative the 1st Putney Scouts have advised that local and Council dignitaries will be invited to the formal unveiling of the new sign and plaque for Alison Small.

MOTION:

- (a) That Council approve the erection of an external sign and the installation of an internal plaque at the Putney Scout Hall in Cleves Park.
- (b) That Council provide support for this initiative by providing \$250 to the 1st Putney Scouts to assist them in procuring the plaque and sign to be funded from the general reserve.



8 ADDITIONAL SKATE PARK OPTIONS WITHIN THE CITY OF RYDE - Councillor Roy Maggio

- (a) That with the huge success of the Meadowbank Skate Park that Council investigate the feasibility for an additional outdoor youth space / skate park at an alternative suitable location which could also include a BMX VRamp and pumptrack.
- (b) That Council allocate \$50,000 funded from Developer contributions to complete this study.
- (c) That a report be provided to Council by the end of the 2019/20 financial year with the outcomes of this investigation.



9 CITY OF RYDE LIBRARY TOY LOAN PROCEDURE - Councillor Roy Maggio

BACKGROUND:

The City of Ryde offers a Toy Library at the North Ryde Library. This service provides loans from a collection of 809 Toys for up to three weeks.

The current procedure allows Toy Library loans to child membership cards only. This primary purpose of this procedure is to ensure a child meets the recommended age range for the toys in the collection of 0 - 7 years. The secondary purpose of only loaning toys to child cards is to limit the number loaned to each family to three for each child. This provision ensures a wide range of suitable toys is available for parents and carers to select from the Toy Library. There is a provision in the current procedure for a one-off loan on a family member's card if the child's card is unavailable; however, this exception does not assist grandparents who regularly care for their grandchildren.

The requirement for a child card for Toy Library loans may create an opportunity for grandparent carers as they may not have a grandchild's card or the grandchild may not have a card. If a grandparent applies for membership for their grandchild, they may not be able to provide the ID required to obtain a child membership card.

To further enhance this valuable service, the procedure should be amended to allow grandparents who are members of the Library to borrow toys on behalf of their grandchildren.

That the City of Ryde amend the procedure for loaning toys at North Ryde Library to allow grandparents who are members of the Library to borrow toys on behalf of their grandchildren.
