How many free permits am I eligible for?

The number of free permits you are eligible for depends on the number of vehicles that are registered to your property and the number of parking spaces on your private property.

To work out how many resident permits you may be eligible for, you will need to count the number of vehicles registered to your property (at a maximum of three (3)) and minus the number of parking spaces on your private property. This will then equate to the number of free resident permits you may be eligible for. In addition all properties in a resident parking scheme may be eligible for one (1) free visitor permit.

- 2 Parking spaces on private property
- 1 Resident permit
- 1 Visitor permit

Total eligibility: 2 permits

Please note: All permits are subject to an eligibility and application process. Proof of vehicle registration for all vehicles registered to a property will be required with each permit application.

What is a 'parking space' on my private property?

A parking space on your private property includes any garage, carport and/or surfaced area for parking, regardless of its current use.

What if I use a 'parking space' for storage?

A garage, carport and/or surfaced area for parking will be considered as a parking space, regardless of its current use.

Can I get a permit for my trailer, boat and/or caravan?

No, the following vehicles are not considered eligible for any permits:

- Truck
- Bus
- Tractor
- Caravan
- Box trailer
- Boat trailer
- Horse float
- Any vehicle 4.5 GVM and over

What if I have more than 3 motor vehicles registered to my property?

Under the Draft Policy we can only provide a maximum of three (3) resident permits and one (1) visitor permit subject to eligibility requirements.

There is a granny flat on my property, will they be eligible for any permits?

Yes, they may be eligible for one free visitor permit.

Can I purchase additional resident permits?

No, since 30 June 2019 residents have not been able to purchase additional residential permits and this will not change.

If I am not happy about this change, can Council change the Draft Permit Parking Policy?

The Draft Permit Parking Policy reflects the requirements of the RMS *Permit Parking Guidelines Version 4.0.* It is mandatory for all Councils in NSW that their policy complies with the RMS Guidelines.

If we can't get any resident permits, can we be removed from a resident parking zone?

Yes, if the majority of properties in the street support its removal from the scheme. In order for a street to be removed from a resident parking zone there is a process that needs to be followed. To begin this process you will need to approach Council with your request separately.
