**WORKS NOTIFICATION**  
**Reserve Street Road Safety Upgrade**  
**Between Miriam Road and West Parade, West Ryde**

The City of Ryde has a legal obligation as the delegated roads authority to repair, maintain and inspect the road.

Noting these obligations, at its meeting Tuesday 23 March 2021, Council resolved to finalise the scope of works and construct a road safety upgrade of Reserve Street, West Ryde to meet the current Australian Standards and legislations. The scope of works has now been completed and we are ready to start construction.

**What will the road safety upgrade include?**

The works will include:

- Construction of kerb and gutter on both sides of the road (with a reduced height of kerb and gutter on the resident's side)
- Minor local widening to asphalt fronting #31A to #35 Reserve Street
- Formalising the existing car parking arrangement, by providing up to thirty-two (32) 90-degree spaces and eliminating all parallel parking on the resident's side
- Installation of appropriate street signage to enforce the car parking arrangement
- Reconstructing of affected driveways to suit new kerb alignment as required
- Road resurfacing and line-marking

**Why can't the road be left as it is?**

An independent Road Safety Audit (RSA) has identified that the road is not compliant with the relevant Australian Standards and legislations. As the road in its current state is not meeting its statutory obligations, Council may be liable for any damages to property and personnel caused by the current condition of the road.

Reserve Street between Miriam Road and West Parade has a narrow road pavement and does not have any kerb and gutter for adequate drainage. The state of the road is deteriorating faster than normal as water is able to seep into the sub-base without a kerb and gutter, posing safety hazards.

Therefore, the road cannot be left in its current condition and Council is required to undertake these works to meet its statutory obligation.

**Are these works associated with the upgrade of Miriam Park Playground?**

No, the upgrade of Miriam Park Playground is separate to this project. Residents will be notified separately regarding the future playground works.

**When will the works take place?**

Works are scheduled to commence in **early October 2021** and are planned for completion by **February 2022**, weather permitting.

The works will be carried out Monday to Friday and some Saturdays between the hours of 7.00am and 4.00pm. Every effort will be made to minimise inconvenience to residents during the construction period.
