Statement to residents: Deferral of Medium **Density Housing Code**

The City of Ryde has commenced proceedings in the Land and Environment Court against the State Government's Medium Density Housing Code (the Code).

You'll recall that the State Government recently tried to impose the code on our citizens against their wishes. The Code allows for blocks of flats in Ryde's quietest streets at a time when the State Government have already targeted our city with enormous housing targets and imposed two priority precincts.

The Council recently led a campaign against the Code's implementation in Ryde. Rather than an exemption, which we requested, the Government only gave the City of Ryde a 1 year deferral, saying that "infrastructure in certain areas needed to catch up.

Since the announcement, Council has been asking for a complete exemption, or at the very least, longer than the 1 year deferral announced by the Minister. The State refused both requests.

The City has no confidence that State infrastructure will improve to a satisfactory level in the 12 months to 1 July 2019, when the Code is due to take effect in the Ryde Local Government Area. The City of Ryde is also concerned with the impacts that development under the Code will cause to our community and environment.

We have had no choice but to commence legal proceedings against the Government to hold them to their promise. We were told that the Code needed to be deferred to allow for new infrastructure. It is clear that the deferral is just to get the Government through the next State Election
