#### Work begins on new skate and scooter park

I am delighted to report that construction has now begun on City of Ryde's new skate and scooter park at Meadowbank Park.

This facility will be state of the art and will include skate and scooter areas for kids of all ages and abilities, a competition deep skate bowl as well as picnic areas for everyone

The new skate and scooter park is just another example of how Council is working hard to provide the community with more quality outdoor spaces.

It is due to open by March next year, weather permitting.

#### Lighting up our sporting venues

The City of Ryde continues to upgrade key sporting facilities across the community.

The latest venues to benefit from this work are Marsfield Park and Gladesville's Monash Park, which will receive much-needed lighting upgrades. The upgrades will bring both fields up to the minimum Australian Lighting Standards. and ensure teams can train in safe and secure conditions.

The work will be funded under Council's Four Year Delivery Plan and with the assistance of grants from Football NSW as part of its Let's Light Up Football campaign.

I would like to give a big thank you to Football NSW for its support. Work on the lighting upgrades at both venues will commence in early 2019.

#### Plant a tree day

Recently, I joined more than 200 residents to plant trees at Laurel Park in Ryde as part of an event staged by the City of Ryde to celebrate National Tree Day.

More than 800 plants and trees were planted which will go a long way to improving the wildlife corridor along Buffalo Creek, which is one of the most vital environmental areas

Council proposes to enter into the following Voluntary Planning Agreement, which is now on Public Exhibition: Voluntary Planning Agreement for 197-223 Herring Road, Macquarie Park NSW 2113 (Lot 100 DP1190494 A, B & C) in association with a Staged Development for redevelopment of Macquarie Shopping Centre incorporating four tower envelopes with maximum heights ranging from 90 to 120 metres; maximum additional gross floor area of 148,000sqm in Development Application - LDA2015/0655 dated 10 November 2016.

**Description:** The above development consent contains deferred commencement condition, which will require the Developer to enter into a Voluntary Planning Agreement (VPA) with Council prior to the consent becoming operational.


