Address: 70 Frances Road Putney (Morrison Bay Park)

Proposal: Proposed Community Garden (Morrison Bay Park) to be used and maintained by members of the local community including those who are retired, live with disabilities or area in high rise developments. The development will include tiered levels of gardens, providing accessible garden spaces for community members, incorporating composting and recycling strategies, and maximising green initiatives.

PANEL CONSIDERATIONS AND DECISION

DEVELOPMENT APPLICATION
