REPORT SUMMARY

This report details Council's performance of its investment portfolio as at 31 January 2021 and compares it against key benchmarks. The report includes the estimated market valuation of Council's investment portfolio and loan liabilities.

Council's return for the reporting period is 1.73%, which is 1.72% above the benchmark figure of 0.01%.

Income from interest on investments and proceeds from sale of investments totals \$2,294K for the financial year to date, which is \$136K above the 2020/21 year-todate adopted budget of \$2,158K.

That Council endorse the Investment Report as at 31 January 2021.


Discussion

Council's Responsible Accounting Officer is required to report monthly on Council's Investment Portfolio and certify that the Investments are held in accordance with Council's Investment Policy and Section 625 of the Local Government Act.

Investment Performance Commentary

Council continues to utilise the Federal Government's current guarantee (\$250K) investing in Term Deposits with a range of Authorised Deposit Taking Institutions (ADI's) on short to medium term investments (generally 30 days to 180 days maturity) where more competitive rates are available.

Whilst Council has moved some of its investment portfolio out to longer terms to lock in future returns, it should be noted that there is approximately \$100.8 million of Council's funds held in Internal Reserves (as at 30 June 2020).

Council's income from investments continues to exceed budgeted expectations, primarily due to Council's cash reserves balances being higher than anticipated.

Loan Liability

Council's loan liability as at 31 January was \$1.3 million which represents the balance of two loans which were established under the Local Infrastructure Renewal Scheme (LIRS). Council receives a 3% interest subsidy payment from the OLG twice a year.

- 1. A \$1.5M 10 year loan drawn down 31 January 2014 at 180 day BBSW +175 basis points for the Children's Play Implementation Plan, which was approved for an LIRS subsidy in Round 2. The interest rate for this loan is reset every six months;
- 2. A \$1.5M 10 year loan drawn down 1 September 2014 at 4.95% for Phase 2 of the Children's Play Implementation Plan, which was approved for an LIRS subsidy in Round 3.










Analysis of investments




Total Funds Invested

Divestment of Fossil Fuel Aligned Financial Institutions

As at 31 January 2021, Council had a total amount of \$47.4 million invested in nonfossil fuel aligned financial institutions. A further \$6 million was invested in unrated financial institutions where their 'alignment status' is unclear/undetermined. It is almost certain all of these unrated financial institutions are non-fossil fuel aligned institutions as their lending profiles are almost identical to other unrated institutions. If it is assumed those institutions are non-fossil fuel aligned financial institutions, then the total amount is \$53.4 million (26% of Council's total investment portfolio).

By way of comparison, Council had \$50.5 million (24.5% of its total investment portfolio) invested in non-fossil fuel aligned financial institutions, as at policy inception on 31 January 2018.

Financial Implications

Council's return for the reporting period is 1.73%, which is 1.72% above the benchmark figure of 0.01%. Income from interest on investments and proceeds from sales of investments totals \$2,294K for the period ending 31 January 2021 and is \$136K above the 2020/21 year-to-date adopted budget of \$2,158K.

Summary

Council's investment portfolio continues to perform well with returns well above benchmark. The recommendation in this report is consistent with Section 625 of the Local Government Act, which deals with the investment of surplus funds by Councils.
