City of Ryde's Senior Coordinator Traffic Transport & Development advised that the request had only recently been received and that City of Ryde's Road Safety Officer will be making contact with the School and organising a warrant-based review of the crossings in the area.

Tucker Street, Ryde

The City of Ryde's Team Leader Traffic Services advised that there is an existing 'BUS ZONE' in Tucker Street, Ryde, currently used as a Bus Layover area by Sydney Buses and that the current Technical Direction TDT 2013/07 recommends the use of 'NO PARKING BUSES EXCEPTED' in dedicated Bus Layover areas.

The Sydney Buses representative advised that this Bus Layover area takes the pressure off Bus Stops and associated 'BUS ZONE' in Devlin Street and advised a preference to retain the existing 'BUS ZONE', rather than 'NO PARKING BUSES EXCEPTED' zone, because the site is located in a commercial area and a 'NO PARKING' zone is likely to be used by stopped drivers.

The RMS representative advised that they will seek internal advice on the matter before reporting back to City of Ryde.
