GENERAL BUSINESS

Timing of traffic phasing - Lane Cove Road and Kent Road

A request was made by the police that the timing of the left hand turn signal from Lane Cove Road into Kent Road be extended. RMS noted the request for further investigation.

Meadowbank Skate Park

The police have received a number of complaints regarding anti-social behaviour in the vicinity of the skate park since its opening.

RMS requested that it would be preferable if the proposed pedestrian crossing be constructed as a raised crossing.

41 and 43 Higginbotham Road

There is a space between the driveways of 41 and 43 Higginbotham Road.

The STA requests that the existing bus zone be extended to include the above location as sightlines at this location are obscured when vehicles park between the two properties.

Belmore and Junction Road

Council.

Council staff advised the RMS representative that the traffic lights at the above location are blacked out.

Flashing speed sign in the vicinity of Ryde Secondary College

Council staff advised that the flashing sign on Buffalo Road is not functioning at present.

Kiss and Ride at Eastwood Public School

The zone has been moved from Shaftsbury Road into Rowe Street and is working well.

School Crossing Supervisor – Eastwood Public School

Council advised that School were informed by RMS that it did not meet the warrant for a school crossing supervisor at the pedestrian crossing on Rowe Street.

Extension of School Zone – Meadowbank Public School

Council has requested that the section of Sutherland Street between Gale Street and Thistle Street be made part of the school zone associated with Meadowbank Public School. RMS indicated that as it does not have an active school frontage, it cannot agree to Council's request.

Pope Street and Smith Street

Changes requested by Council to the pedestrian lights at this intersection are being considered by RMS.

Bus Shelters - Victoria Road

A new contract with Adshell has been entered into by Hunters Hill Council in relation to bus shelter advertising. This has resulted in the removal of a number of bus shelters along Victoria Road in the vicinity of Huntleys Cove.

New shelters will be erected by the new contractor but the timing of these works is not known.

College Street Gladesville

Clarification was sought regarding RMS approval for the closure of College Street. RMS requested a TMP for the permanent closure be submitted.

The next Ordinary Meeting of the Ryde Traffic Committee will be held on Thursday, 15 August 2019.
