### **REPORT SUMMARY - TENDER EVALUATION**

Request for Tender (COR-RFT- 24/12) for "Construction of two (2) new netball Courts at Meadowbank Park". Closing Date 15 January 2012.

Council has sought tender submissions from suitably qualified specialist contractors to construct two netball courts at the Meadowbank Park Netball Complex, Adelaide Street, Meadowbank.

Council resolved 11 December 2012 meeting, item 22 to accept the offer from ERNA a contribution of \$67,190 (GST exclusive) contribution by the Eastwood Ryde Netball Association.

The Tender Evaluation Panel assessed all conforming tenders and recommended that the Council accept the tender from Court Craft Pty Ltd.

#### **RECOMMENDATION:**

- (a) That Council accept the tender from Court Craft Pty Ltd for the construction of two (2) new netball courts at Meadowbank Park Netball Complex, Adelaide Street, Meadowbank to the amount of \$128,156 (GST exclusive) as recommended in the Tender Evaluation Report.
- (b) That Council advise all the respondents of Council's decision.

#### **Tender Details**

Council's preferred method of tendering was adopted by advertising in the Sydney Morning Herald, sending documents to the market place via the eTender Portal Tenderlink and sending documents to selected companies. The tenders were released on 12 December 2012 and closed 15 January 2013.

At the time of closing, the following companies submitted tenders. These companies are listed in alphabetical order;

#### **Evaluation**

A tender evaluation committee comprising three (3) Council officers assessed all the tenders against the following criteria:

- Conforming tender
- Fixed lump sum price
- Project programme
- Proven experience and resource capability
- Insurances
- Work Health and Safety
- Environmental consideration
- Sustainability and considerations for Project Program

The tender revaluation committee evaluated the tender submitted by Court Craft Pty Ltd as the best value submission when compared against the evaluation criteria.
