

#### Dear Mr Johnson

Thank you for your letter of 29 September 2014 outlining your council's concerns in relation to the *City of Sydney Act 1988* (the Act) recently debated in the NSW Parliament

As you may be aware, NSW Parliament's Joint Standing Committee on Electoral Matters (the Committee) conducted an 18-month inquiry into the 2012 local council elections. The inquiry included both a public and targeted call for submissions. In its final report, the Committee found that non-residents eligible to enrol to vote in City of Sydney elections had been effectively disenfranchised by an unnecessarily complex and bureaucratic process.

The City of Sydney Amendment (Elections) Bill 2014 (the Bill) passed the Parliament on 17 September 2014 including additional amendments to address issues of fairness and to improve the operation of the Act.

The Government responded to concerns raised through the parliamentary process and made a number of important amendments to the Bill to ensure that in future City of Sydney Council elections businesses would not be disenfranchised and that the elections would be administered effectively. These amendments included:

- ensuring businesses operating in shopping centres retain eligibility to vote;
- a provision allowing the City of Sydney to request help to run the election; and
- the model would only apply to the City of Sydney.

Key features of the legislation as passed through Parliament include:

- Making the rules for non-residential voters consistent and fairer for different kinds of businesses, setting a maximum of two eligible persons to be enrolled per business, including for each business operating in shopping centres;
- Non-residential electors will only be able to vote once in the City of Sydney elections:
- To be eligible to vote, a non-residential elector will need to be an Australian citizen who lives in NSW;
- Non-residential electors will now be automatically enrolled to vote;

- The City of Sydney, consistent with all other councils in NSW, will be responsible for preparing and maintaining the non-residential roll and will be able to engage an appropriately skilled service provider to assist it in doing so;
- The electoral roll will be regularly updated, available for public inspection and verified by the Electoral Commissioner to ensure transparency and integrity;
- The changes will only apply to the City of Sydney. Possible extension to other economic centres may be considered in the future.

I hope this information will address the Council's concerns.

#### 10/50 Vegetation Clearing Entitlement Area

I refer to the new laws regarding the clearing of trees and vegetation within bushfire prone areas. These laws are supported by the 10/50 Vegetation Clearing Code of Practice which came into effect on 1 August 2014. Council made an extensive submission regarding the Code of Practice which raised significant concerns regarding the proposal. This submission has been enclosed.

At its meeting on 12 August 2014, Council's Code of Practice was discussed and in response, Council resolved to:

That the Acting General Manager write to the Minister of Environment and the members for Ryde and Lane Cove requesting their representation to the Minister for Police and Emergency Services and consideration of the City of Ryde's submission on the Vegetation Clearing amendment to the Rural Fires Act.

As such, I write to request your assistance in undertaking representation to the Minister for Police and Emergency Services regarding the consideration of Council's submission. It is disappointing the Code of Practice has been brought into force 9 days after the Public Exhibition period closed with no amendments.

I refer your letter on behalf of City of Ryde Council to the Minister for the Environment, Rob Stokes MP, regarding the 10/50 Vegetation Clearing Rule and Code of Practice (10/50 Rules). Your letter was referred to the Office of Environment and Heritage (OEH) and I have been asked to reply.

While it is imperative that NSW home owners have appropriate tools to protect their homes for the bushfire season, it is disappointing that a small minority have sought to take inappropriate advantage of the rules. We need to make sure we get the correct balance between conservation and bushfire protection.

The 10/50 Rules are administered by the NSW Rural Fire Service (NSW RFS) under the *NSW Rural Fires Act 1997*. Following community feedback, the NSW Rural Fire Service Commissioner has announced changes to the 10/50 Vegetation Clearing Entitlement. This includes a reduction of the 10/50 entitlement area for Category 2 Bush Fire Prone Land, from 350 metres to 150 metres. Additionally councils will have the ability to reclassify smaller parcels of vegetation.

The NSW RFS has also immediately commenced the formal review of the 10/50 scheme (originally scheduled for one year after the Rules' introduction). Details on how the community can provide feedback can be found on the NSW RFS website at www.rfs.nsw.gov.au. I encourage you to submit any appropriate comments.

As the NSW Rural Fire Service has responsibility for the implementation and review of the 10/50 Rules, I have referred a copy of your correspondence to the Deputy Commissioner, NSW Rural Fire Service, Mr Rob Rogers AFSM, for his consideration.

Thank you for your letter received by the Minister for Police and Emergency Services, the Hon Stuart Ayres MP regarding the 10/50 Vegetation Clearing Entitlement. The Minister has asked me to reply on his behalf.

I am advised that since the legislation was introduced on 1 August 2014, some concerns have been raised, in particular, regarding the entitlement area. I understand that the NSW Rural Fire Service has written to all relevant councils to advise of changes that have now been introduced.

The NSW Rural Fire Service also commenced the formal review of 10/50 on 1 October 2014 to allow people to comment and provide additional feedback. Submissions for to the review can be made to 10.50@rfs.nsw.gov.au until 14 November 2014.

I have also been advised that the NSW Rural Fire Service has facilitated a number of workshops for Councils across the State, where representatives from the Office of Environment and Heritage and the Department of Planning also attended to assist with addressing concerns.

Your correspondence has been forwarded to the NSW Rural Fire Service and will be considered as a part of the review.

I encourage Councils to continue working with the NSW Rural Fire Service to ensure that your community is appropriately prepared for the bush fire season.
