

Discussion

The Our Sporting Future Conference will be presented by the Australian Sports Commission (ASC) on 21 to 23 October 2015 at the Gold Coast Convention and Exhibition Centre.

A copy of the Conference Program is **ATTACHED** (Attachment 1). The Conference objectives and outcomes are as follows:-

Conference Objectives

- Examine contemporary issues and explore growth opportunities in sport;
- Address the long term outlook and sustainability of Australian sport; and
- Provide participants with professional development and networking opportunities.

Conference Outcomes

- Deliver the long term (2030) outlook for sport;
- Showcase sustainability in Australian sport;
- Reinforce cultural diversity; and
- Provide relevance to high performance sport and community sport administrators.

This report is presented to Council as a result of an expression of interest received from Councillor Maggio on 20 August 2015 to attend this Conference.

Financial Implications

The following is a summary of costs that would be incurred per person for attendance at the Conference:

- Registration \$1,200.00.
- Flights approximately \$450.00 return.
- Accommodation approximately \$840.00 for three nights (20 October to 22 October 2015).

In addition to the above summary, it is anticipated that additional costs for incidentals, meals and taxi fares would also be incurred. This would be determined after the Conference.

The total cost for attending this Conference would approximately be \$2,500.00 per person (excluding meals, incidentals and taxi fare charges).

Currently there is an allocation of \$30,000 in the 2015-2016 budget for Councillor attendance at conferences. The table below outlines an estimation of the balance remaining.

The amount remaining in the budget is \$21,024 (however this is dependent on confirmation of Councillor attendance tot the Local Government NSW Annual Conference at Council's Meeting on 8 September 2015).

Policy Implications

There are no policy implications through adoption of the recommendation. The Policy on the Expenses and Facilities for the Mayor and Other Councillors sets out the entitlements for Councillors attending such Conferences.

ATTACHMENT 2 is the Guidelines for Councillor Attendance at Conferences. The Guidelines provide that in addition to the Local Government Association Conference and the Australian Local Government Conference, every Councillor is entitled to attend a conference in NSW, Canberra, metropolitan Brisbane or metropolitan Melbourne. The Guideline provides that a Councillor can attend more than one conference per year but this determination will be dependent on budgetary constraints and with an emphasis on ensuring that all Councillors have equal access to attend conferences.

Other Options

Council can resolve not to send a Councillor to this Conference.







KEYNOTE SPEAKERS

MASTER OF CEREMONIES - NICOLE DAWN LIMINGSTONE

An Australian former competitive swimmer, Olympic silver medallist, and a television sports commentator and radio presenter. Livingstone competed for Australia in three summer Olympics - 1988, 1992, and 1996 winning both individual and team medals. She was an Australian Institute of Sport scholarship holder.

She retired from swimming after the 1996 Summer Olympics in Atlanta, Georgia, and joined the Australian sports network Nine Network as a host of Nine's Wide World of Sport, and a commentator for swimming.

Livingstone is currently a radio presenter for Melbourne station SEN 1116 and presenter at Network Ten and also a panelist and fill in presenter for Carrie Bickmore on The Project.

She is active in promoting drug-free sports in Australia and is involved in the Australian Olympic Committee's "Live Clean, Play Clean" anti-doping education program. She is also a board member of the Australian Sports Drug Agency (ASDA), whose mission is to combat drug use in sports.

She held the Australian record for the 200 m backstroke, with at time of 2:10.20, set on 31 July 1992 at the 1992 Summer Olympics in Barcelona, Spain for 16 years. Meagen Nay broke the Australian record twice at the 2008 Australian Olympic Trials. Notably, she is the only Australian swimmer to have competed in six successive Pan Pacific Swimming Championships. In 1995, the State Transit Authority named a RiverCat ferry after Livingstone. Livingstone was awarded the Order of Australia Medal in 1997 for service to swimming as a representative at state, national and international levels. [2]

Livingstone worked for Wide World of Sports as a host of the self-titled program and as a host of Sports Saturday. She was host of Any Given Sunday with Mick Molloy in 2006.

In March 2007, she was appointed the sports presenter on Nine News PM Edition. She was replaced by Tim Sheridan.

In November 2008, Livingstone resigned from the Nine Network to work for Network Ten's new sports channel One HD which commenced in 2009. Livingstone's final appearance on the Nine Network was on Nine's Wide World of Sport.

In 2011, she was a fill in presenter on Network Ten's Sports Tonight and a panellist on Thursday Night Live.

For the 2012 London Olympics, she and Bruce McAvaney provided swimming commentary for International Olympic Committee's English language international feed.

In 2014, Livingstone made a cameo appearance on Neighbours, presenting for Network Ten, after the character Josh Willis [Harley Bonner] qualified in swimming for the Commonwealth Games

BEN ROBERTS-SMITH

Ben Roberts-Smith served with distinction in the Australian Army and Special Air Service Regiment. His service included operational deployments to East Timor, Fiji, Iraq, and Afghanistan. He is a recipient of the highest award in the Australian military honours system, the Victoria Cross for Australia, awarded in 2011 for the most conspicuous gailantry in action in circumstances of extreme peril in Afghanistan. Ben was also awarded the Medal for Gallantry in 2006 and the Commendation for Distinguished Service in 2013.

Since retiring from the Armed Forces, Ben has been a leading strategic advisor to Government and industry on a broad range of defence, security and personnel issues. Recently, Ben was appointed to a full time, corporate management role with the Seven Network. Ben is the Deputy Chair of the Prime Minister's Advisory Council for Veterans Mental Health and is also a member of the Queensland Veterans Advisory Council. In November 2014, Ben was appointed as Chair of the National Australia Day Council.

Ben is currently studying towards a Masters of Business Administration at the University of Queensland. He has an Advanced Diploma in Management and Diploma in Government and Government Security. He is a Graduate of the Australian Institute of Company Directors [GAICD] and a Fellow of the Australian Institute of Management (FAIM). Ben is Patron of the White Cloud Foundation who assist suffers of depression and also of the Wandering Warriors who support current and ex-servicemen. He is a National Ambassador for Legacy.

Councillor Attendance at Conferences Guideline

Related Policy

This guideline sets out the criteria to determine the attendance of Councillors at Conferences It relates to the Policy on the Payment of Expenses and Provision of Facilities for the Mayor and Other Councillors.

Guidelines

Council acknowledges the value of Councillor attendance at conferences to enable them to be both knowledgeable and current on issues affecting the City of Ryde. In order to ensure that attendance at Conferences is equitable, transparent and consistent, attendance will be limited as follows:

- 1. Local Government Association Conference the number of voting delegates plus one. Details of the delegates and attendee to be determined by resolution of Council.
- 2. Australian Local Government Association Conference.
- 3. In addition, to 1 and 2 above, every Councillor is entitled to attend one conference in either NSW, Canberra, metropolitan Brisbane or metropolitan Melbourne. The conference must directly relate to the business of Council. More than one Councillor may attend the same conference if Council resolves that this will be beneficial for both Council and the Councillors concerned.
- 4. Within 2 months after the conference the attending Councillor must report to Council on the proceedings of the conference. That report will be included in the Councillors Information Bulletin.
- 5. No Councillor can attend a Conference without the prior approval of Council. Reports to Council are to include details of the Conference and an estimate of the associated costs including registration, transport and accommodation.
- 6. Council may resolve that a Councillor can attend more than one conference per year but this determination will be dependent on budgetary constraints and with an emphasis on ensuring that all Councillors have equal access to conferences.
- 7. Each year, as part of the review of the Policy on the Payment of Expenses and Provision of Facilities for the Mayor and Other Councillors, Council officers will provide a full report of expenditure and Conference attendance by Councillors.
