
**10 INSTALLATION OF LOCKABLE CHARGING STATIONS IN
LOCAL LIBRARIES - Councillor Jordan Lane**

MOTION:

- (a) That Council note that In house loans of battery charge units (power banks) and cables are already available at all City of Ryde Libraries since June 2018.
- (b) That Council Staff prepare a report to investigate the feasibility of replacing the current service with lockable mobile device charging stations at all City of Ryde operated libraries.
- (c) That the report to also include funding options from an appropriate funding source as determined by the General Manager.

11 PAINT4FREEDOM LOCAL COMMUNITY ART COMPETITION - Councillor Jordan Lane

BACKGROUND

Modern-day Slavery is a serious global human rights issue impacting an estimated 21- 45 million individuals from within 167 countries including Australia. Human trafficking is akin to Modern-day Slavery. It occurs when people are forced into exploitative situations for the profit of others.

As contemporary systems of slavery have evolved, new definitions, including trafficking and distinguishing child slavery from child labour, have also developed.

Men, women and children are exploited for a wide range of purposes, including forced labour, sexual exploitation, domestic servitude, and child soldiers. While trafficking for sexual exploitation is more commonly reported among women and girls, it can also happen to boys.

Modern-day Slavery and human trafficking are for the most part hidden crimes with the full scale globally not clearly known.

Human trafficking is different to people smuggling. People smuggling is a crime against a country with people illegally smuggled across borders. Human trafficking is an exploitative crime against an individual.

While people consent to being smuggled, human trafficking does not involve consent of those being trafficked. People smuggling is always across borders, while this is not necessarily the case for trafficking. And whereas people smuggling has a final destination, human trafficking involves ongoing exploitation usually until those being trafficked either escape, are rescued or die.

Slavery was prohibited under the 1948 Universal Declaration of Human Rights, which states: "No one shall be held in slavery or servitude: slavery and the slave trade shall be prohibited in all their forms."

The Paint4Freedom Art Competition is a National Art Competition consisting of four levels of competition being Local Community (Local Government / Council territory) / Regional / State / National Competitions, Exhibitions and Finals Judging, designed to help better educate Australians and the world, about the tragedy of Modern-Day Slavery.

MOTION:

- (a) That Council recognise the abhorrent practices of modern-day slavery; human trafficking; forced labour; child soldiers & forced prostitution here in Australia and globally.
- (b) That Council delegate the General Manager to work with Paint4Freedom and local clubs like Rotary and others where possible to organise a Local Community art competition between 1 July and 31 December 2019.
- (c) That Council Staff prepare a report with possible timeframes and expected financial implications.

12 SAFE FOOD HANDLING AT COUNCIL EVENTS AND COUNCIL SPONSORED EVENTS - Councillor Dr Peter Kim

MOTION:

That the General Manager:

- (a) Promote the NSW Food Authority education resources on *Temporary Food Handling, Storage and Hygiene* for food stall holders participating in Council events and Council supported events including resources in community languages.
- (b) That Council's Environment Health Officers provide a one-on-one meeting (with interpreters if required) to any food stallholder requesting clarification on the NSW Food Authority guidelines.
- (c) To continue improving the hygiene quality of food stall holders, repeat offenders will face prompt compliance and enforcement action (including revoking permits) to protect public safety.

**13 PIANO/KEYBOARDS IN RYDE COUNCIL COMMUNITY HALLS -

BACKGROUND

The City of Ryde Council resolved on 26 February 2019 to investigate the feasibility of providing a piano at the West Ryde Community Hall. I have received a request by residents that the Council also considers the supply of piano or keyboards in Councils other community halls. Noting that, Council already has three pianos in our six community halls and the development of a new Halls and Facilities strategy is underway.

This motion aims to expand the current resolution to other Council community halls.

MOTION:

- (a) That Council staff investigate the costs and options to provide pianos in all community halls, in the Ryde local government area.
- (b) That staff also consider second hand and/or donated pianos.
- (c) That a report is presented to Council with options once the investigation is complete.

14 MULTILINGUAL INTERPRETER SERVICE - Councillor Dr Peter Kim

BACKGROUND:

I have received community concerns that Ryde residents with poor English skills feel embarrassed to approach the Council and speak at Council meetings and committees. Poor English language skills should not be a barrier to direct participation in our democracy. This motion aims to remove this barrier in participation for non-English speaking Ryde residents.

MOTION:

- (a) That a twelve (12) month trial be implemented providing multilingual interpreter services for speakers that have provided the Council with sufficient notice to be listed for public participation at Council meetings and committees.
- (b) That if successful this service should be made permanent and Councils Code of Meeting Practice amended accordingly.
- (c) That an appropriate budget for the trial is allocated from general revenue.

**15 ROWE STREET EAST CAR PARK COMMUNITY CENTRE
PROPOSAL - Councillor Dr Peter Kim**

BACKGROUND:

Due to the lack of community space across the Ryde LGA, an option has become available to construct a community centre in conjunction with the proposed Rowe Street East car park development. This is an excellent low-cost opportunity to add community space in Eastwood.

- (a) That the General Manager prepare a report into the financial viability of constructing a community centre in conjunction with the proposed Rowe Street East car park development.
- (b) That the report is to include details about relevant planning controls and approval pathways required and timing options for construction.

**16 EAST PARADE, EASTWOOD - TRAFFIC CONGESTION -

- (b) That the outcome of the consultation be notified to all who participated.
- (c) That a media release of the outcome is distributed to local newspapers including community language newspapers.
