City of Ryde 2017 "#RydeVision2028 Priorities" Competition - Terms and Conditions

The following terms and conditions apply:

- 1. The "#RydeVision2028 Priorities" competition commences at 2.00pm Australian Eastern Daylight Time (AEDT) on Wednesday 11 October 2017 and closes at 5.00pm AEDT on Sunday 3 December 2017.
- 2. The Promoter is City of Ryde of Binary Centre, Building 0, Level 1, 3 Richardson Place, North Ryde NSW 2113.
- 3. Entry into the promotion is open to residents of NSW, Australia only who are 18 years or older.
- 4. Employees, contractors and councillors of the Promoter are not eligible to enter.
- 5. Only one entry per person, per Outcome is permitted.
- 6. To be eligible, entrants must submit a name for a 'Ryde Vision 2028 Outcome' using the online form at <u>www.ryde.nsw.gov.au/rydevision2028</u>.
- 7. Entries submitted as part of this competition must:
 - a. Be suitable for a professional public document
 - b. Represent the City of Ryde outcome and be understood by the majority of the community
 - c. Not infringe the copyright, privacy or any other rights of any third party
 - d. Not capture recognisable individuals or brands
 - e. Not be offensive or obscene, including containing offensive language or depicting any profanities, violence or any other inappropriate behaviour
 - f. Not discriminate against or vilify a person or section of the community on account of race, ethnicity, nationality, sex, age, sexual preference, religion, disability or political belief.
- 8. Once submitted, the entrant cannot alter or delete the entry.
- 9. Participation in the promotion by completing the above step is deemed acceptance of these terms and conditions.
- 10. Participants who do not provide a valid Australian telephone number, their association with the City of Ryde local government area and their name will have their entry voided.
- 11. In the event that an entrant's contact details change during the competition period, it is the entrant's responsibility to notify the Promoter.
- 12. The prize draw is open to all qualifying entrants who submit their online entry between 2.00pm Australian Eastern Daylight Time (AEDT) on Wednesday 11 October 2017 and 5.00pm AEDT on Sunday 3 December 2017. No purchase is necessary.
- 13. The Promoter will choose one (1) winning entry for each of the seven (7) Priorities. Each winning entrant will win a gift card to the value of one hundred dollars (\$100), making a total prize pool of \$700 in gift cards.

- 20. City of Ryde reserves the right to not choose a winner from the entries received for each of the seven (7) Priorities, should the entries not meet the merits of this competition. If no winning entry is chosen for an Outcome the one hundred dollar (\$100) prize allocated will be forfeited.
- 21. The winners will be notified by telephone and/or email on Wednesday 13 December 2017 and will be provided with details of how to redeem the prize.
- 22. The winning entries may be published in City of Ryde documents and on City of Ryde social media channels. They may also be published on the ryde.nsw.gov.au website and in local press.
- 23. By entering the prize draw, the winner and runners-up consent to their name being published and to participate in any publicity accompanying or resulting from this promotion in printed and/or online formats without requiring further payment by the City of Ryde or further consent from the winner or runner up.
