The plan will include practical strategies and actions to address regional and local barriers and opportunities to a more socially inclusive and healthy community.		
The plan identifies four key focus areas, nominated by people with disability, as being of primary importance in creating an inclusive community. These are:		
<ul> <li>Developing positive community attitudes and behaviours</li> <li>Creating liveable communities</li> <li>Supporting access to meaningful employment</li> <li>Improving access to services through better systems and processes.</li> </ul>		
The DIAP will be positioned into Council's core business and integrated yearly over a 4 year period into Council's Delivery Program and Operational Plan to ensure that Council and their staff at all levels consider inclusion of people with disability as part of their everyday business.		
A draft copy of the Plan will be available by May/June for comment and public viewing soon after that. The DIAP will be submitted to the Disability Council NSW and will be reported against on a yearly basis.
