LDA2021/0155

29A Boyce Street, Ryde

Proposal: Sports field lighting to Gannan Park including the installation of four (4) 22m high light poles and associated earthworks. The lighting would be used for training and social sports with the proposed hours of operation being:

- Winter (April to August): Monday to Friday 4pm to 9:30pm
- Summer (September to March): Monday to Friday 6pm to 9pm.

PANEL CONSIDERATIONS AND DECISION

The Panel considered the matters listed at item 6, the material listed at item 7, and the material presented at meetings and briefings listed at item 8 in Schedule 1.

DEVELOPMENT APPLICATION

The Panel determined to **approve** the development application as described in Schedule 1, pursuant to Section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

REASONS FOR THE DECISION

The Panel determined to **approve** the application for the following reasons:

- 1. The proposal is consistent with the objectives of the zones.
- 2. The proposal satisfies the statutory provisions set out in the Environmental Planning and Assessment Act 1979.
- 3. The proposal, with appropriate conditions of consent, results in no unreasonable adverse impact to adjoining properties and the surrounding environment.
- 4. The proposal is not contrary to the public interest.

The Panel adopts the recommendation and reasons for approval as outlined in the Assessment Officer's report.

CONDITIONS

The development application was approved subject to the conditions in the Council assessment report with the following addition to condition 45:

45 Light Spill The light spill at the adjoining residential boundaries to comply with the requirements of AS 4282 - Control of the obtrusive effects of outdoor lighting. Appropriate glare shields are to be fitted to each of the proposed lights to minimise light spill to surrounding residential properties.

CONSIDERATION OF COMMUNITY VIEWS

In coming to its decision, the Panel considered written submissions made during public exhibition and heard from one objector who addressed the panel.

The panel considers that concerns raised by the community have been adequately addressed in the assessment report. No new issues were raised during the public meeting.
