SCHEDULE

(1) Plans
The application must be accompanied by at least three (3) sets of plans, drawn to a suitable scale and coloured to distinguish between new and existing work.
The plans must include:

- (a) A site plan showing the location of the flue and all buildings on the land and any adjacent buildings within a 15 metre radius
- (b) A floor plan showing the location of the solid fuel heating appliance, the hearth and any safety clearances or heat shield provided.
- (c) Elevations showing the height of the flue above the roof and any adjacent buildings within a 15 metre radius.
- (d) A section showing how the solid fuel heating appliance will be installed, including the construction of the hearth, any safety clearances or heat shield provided and the construction of the flue.

(2) Specifications
The application must be accompanied by at least three (3) sets of manufacturer’s specifications for the solid fuel heating appliance.

(3) Certification
The application must be accompanied by a certificate of compliance from the manufacturer of the solid fuel heating appliance stating that the appliance complies with:

- (a) AS/NZS 4012:2014 Domestic solid fuel burning appliances—Method for determination of power output and efficiency, and
- (b) AS/NZS 4013:2014 Domestic solid fuel burning appliances—Method for determination of flue gas emission.
